- ◆ Prior to serving a shipper, and at times thereafter, U.S. Government regulations may require a shipper to provide SHENGSHI with a limited Power of Attorney to execute Customs export declarations.
- ◆ Prior to serving a Shipper, and at times thereafter, SHENGSHI may require appropriate credit information and signature of a Credit Application or Agreement consistent with terms described herein.
- ◆ Delinquent invoices shall constitute a general lien against client's remaining documents and goods in the custody or control of SHENGSHI.
- ◆ SHENGSHI assumes no liability for Customs penalties, third -party claims or charges, or losses to the exporter beyond our reasonable control. The limit of SHENGSHI's liability in cases of negligence shall be ten (10) times its fee collected for the subject transaction unless otherwise specified by Customs Regulations. We further adhere to the Standard Conditions adopted by The National Customs Brokers and Forwarders Association of America, Inc., which are reprinted on the reverse side of this schedule.
